El.En.: The BOD releases the six months financials as of June 30, 2008

Selected consolidated figures as of June 30, 2008

Florence, August 29th2008 – The Board of Directors of El.En. SpA, leader on the laser market and listed on the STAR Segment of the Italian Stock Exchange, met today and released the six months financials as of June 30th, 2008. The positive results, both in terms of revenues and of net and operating income, confirm the success of the Group's strategies which allow to achieve growth rates higher than the market and our direct competitors.

Consolidated revenues for the six months are 113,6 millions of Euro, up 26,2% on the 90 millions of Euro of the first six months of 2007. The result reflects the excellent behavior in all the market segments covered by the group.

The growth in the *industrial segment* has been very significant (up 41%), gathering the first fruits from the activities initiated during year in 2007 in China and in Brazil, and enjoying the success of certain products within the laser sources product range. Also the *medical/aesthetic segment* has performed well, with more than 84 millions in revenues for the six months, close to 75% of the group's total revenues, and highlighting El.En. as the most important and innovating entity in the market.

Gross Margin is equal to 64,1 millions of Euro up 26,6% on the 50,6 millions of Euro of the previous year, with an unchanged impact on revenues (56%).

EBITDA is 17,9 millions of Euro up 61,7% on the six months of 2007; impact on revenues increases from 12,3% to 15,8%.

EBIT marks an 80,3% increase and reaches 15 millions of Euro, registering a material increase in the impact on revenues which from the 9,3% of the first six months of 2007 grows to 13,3% in the six months of 2008.



Pre tax income for the period is 15,8 millions of Euro, more than doubled on the 7,6 millions of Euro registered as of June 30, 2007.

The Group closes the first semester of 2008 with a **net income** equal to 5,3 millions of Euro.

The **Net Financial Position** of the El.En. Group as of June 30, 2008 is positive for 51,9 millions of Euro.

The consolidated financials for the first six months of 2008 excluding Cynosure from consolidation show consolidated revenues for 69,3 millions of Euro (up 34% on the six months of 2007); EBITDA at 8,4 millions of Euro (up 54%); EBIT at 6,9 millions of Euro (up 72,9%); pre tax income at 6,5 millions of Euro (up 77,6%) and net income at 4 millions of Euro. The Net Financial position is positive for 8,1 millions of Euro.

Based on the financial results of the first six months of 2008 the **El.En. group confirms the 2008 annual targets** that had been previously disclosed, which involve annual revenues for 140 millions of Euro (+27%) and EBIT of 14 millions of Euro. We hereby remind that, also due to the policy of Cynosure Inc. not to disclose any financial guidance, **the forecast herein provided is related solely to the consolidated financials excluding Cynosure Inc. from consolidation.**

The management has expressed its satisfaction for being able to confirm such ambitious targets within the current economic environment, which has caused our reference markets to become more uncertain and less brilliant.

The manager in charge for the Company's financial reports, Dr. Enrico Romagnoli, declares, pursuant to paragraph 2 of Article 154-bis of the Consolidated Law of Finance, that the accounting information contained in this press release corresponds to the document results, books and accounting records.

El.En., an Italian company, is the parent of a high-.tech industrial group operating in the optoelectronics sector. Based on proprietary technology and multidisciplinary know-how, the El.En Group manufactures laser sources (gas, semiconductor, solid-state and liquid) and innovative laser systems for medical and industrial applications. The El.En. Group is the laser market leader in Italy and among the top operators in Europe. It designs, manufactures and sells worldwide:

- Medical laser equipment used in dermatology, cosmetics, physiotherapy, dentistry and gynecology;
- Industrial laser systems for applications ranging from cutting, marking and welding metals, wood, plastic and glass to decorating leather and textiles and restoring/conserving artwork;
- Laser systems for scientific research

EL.EN has been listed on the Star (MTAX) of Borsa Italiana. Its market floatation is approximately 40% and its market capitalization amounts to €120 million.
